

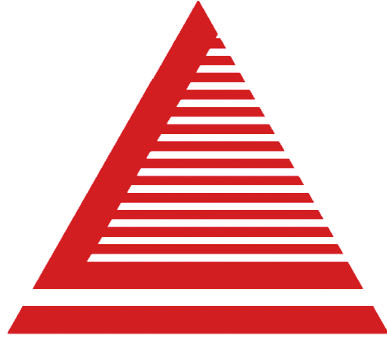

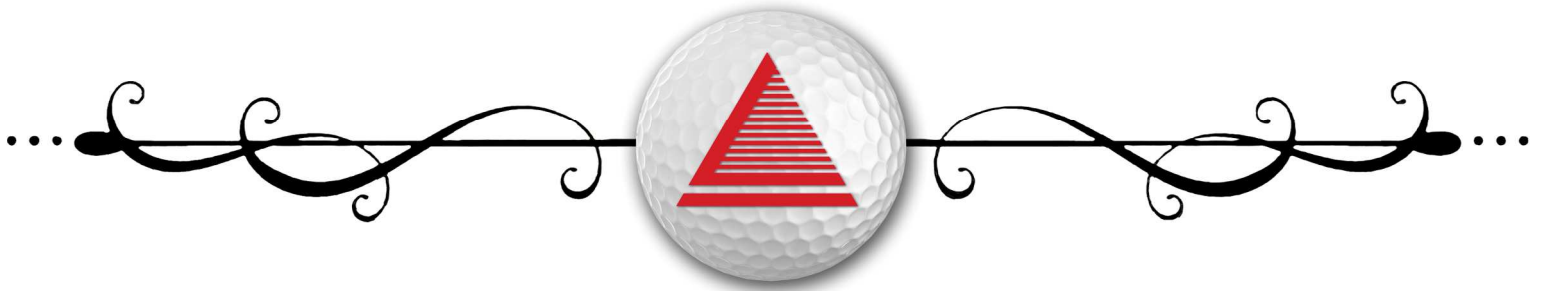
ABOUT THE FOUNDATION

Bobby Benson Center is a residential facility dedicated to offering Hawaii's adolescents the assistance they need in overcoming substance abuse. Bobby Benson Center is also a community based social-learning model program designed to provide our Keiki's, ages 13-17, with the opportunity to gain the skills needed to develop a lasting recovery from dependency on drugs or alcohol. Specifically, the treatment program is designed to help break through the denial of drug and alcohol addiction, develop skills to manage the ups and downs of life and begin taking personal responsibility for actions.

Named after 15 year old Bobby Benson, who died in 1984 after a short life troubled by drug abuse, Bobby Benson Center located in Kahuku on the North Shore of Oahu currently maintains a facility with a licensed 30 bed capacity that includes four separate cottages on a beautiful landscape. Drug and alcohol addiction affect not only the youth, but all who love them. Our residential treatment program offers a supportive environment in which teenagers and their families can acquire the knowledge and skills needed to overcome the cycle of drug and alcohol addiction. We firmly believe that our residential program provides a path to a brighter future for those struggling with chemical dependency. We invite you to explore our website and discover the Bobby Benson Center has to offer – a place of refuge, help and hope!

The mission of the Bobby Benson Center is to "free youth in Hawaii from chemical dependency and co-occurring disorders through residential treatment services employing best practices for the youth and their families".

Lawakua Charitable Fund is deeply honored to be nominated as a grant recipient from the Pyramid Insurance Charitable Foundation. Starting in 1977, under the leadership of Matt Levi, Lawakua has been teaching low income housing children the martial art form of Kajukenbo to foster students with good character, leadership ability, and academic achievement. Our Lawakua students span from Halawa Housing, Kuhio Park Terrace, Mayor Wright Homes and Kalihi Valley Homes. In 2015, Lawakua Charitable Fund became an independent 501(c)(3) non profit organization. Kajukenbo is deeply rooted in Hawaii. In the late 1940s, five masters developed the martial art of Kajukenbo in Palama Settlement. The masters combined the best techniques of their respective arts into one. Kajukenbo is an acronym for karate, judo, jujitsu, kenpo karate, Chinese boxing (kung fu), and American-style kickboxing. Martial arts provide the students with structure, an element most do not receive in their life at home. Lawakua and its volunteers' investment into the students' future highlight the healthy and right path forward by which the students can transcend their current socioeconomic status.

The Lawakua Kajukenbo Club has evolved over the decades and today there are over 100 students participating. All Kajukenbo and weekly academic tutoring classes are available to the students free of charge. In addition to the martial arts training, nearly 20 Lawakua students are enrolled in private schools, including Damien Memorial School, Hawaii School for Girls at La Pietra, Maryknoll, Iolani, Sacred Hearts Academy, St. Louis, and Island Pacific Academy. The majority of students attending private schools are on tuition-free scholarships provided by those schools. However, non-tuition costs for books, lunches and school-related activities are paid for by donor contributions to Lawakua. We are extremely proud that many of our students have honor roll grade point averages, and also participate in student council both in their public and private schools. It is our hope to increase the number of students training with us, but to also maintain a high quality of martial arts training to inspire positive character development and academic achievement. With the support of the Pyramid Insurance Charitable Foundation, Lawakua will be able to increase its ability to better serve our students. Thank you for your consideration.

Mun Lun Chinese School in Honolulu, Hawaii is the oldest and largest daily Chinese-language school in the USA. 105 years ago in 1911, the school was founded to educate the children of Hawaii in Chinese culture, language and academics. Open to students of all ethnicity, the school currently boasts over 340 daytime (afternoon and Saturday) students in grades 1 through 9. Housed in its own facilities at 1290 Maunakea Street, the school consists of a single two-story building originally dedicated in 1971. Currently undergoing a facelift and modernization, recently completed window replacement, and soon-to-be upgrades in its electrical system and addition of air conditioning are the first major improvements to the building in 45 years. Although these improvements are a strain to the current budget, they were deemed urgently necessary for the security, health and safety of school students and faculty. Administratively, the school is run by board of directors of the Mo Hock Ke Lock Bo (dba Mun Lun School) corporation; and holds a 501(c)3 tax exempt status with the Internal Revenue Service.

Poi Dogs & Popoki (PDP) is a nonprofit animal welfare organization committed to saving lives by ending pet overpopulation, helping families keep the pets they have, and returning lost pets to their owners. PDP provides island-wide access to affordable sterilization through The Big Fix, a mobile spay and neuter clinic. Last year, The Big Fix sterilized more than 3,000 cats and dogs – from Waianae to Waimanalo. Spay and neuter is the single most effective strategy to reduce unintended pregnancies which contribute to the thousands of animals dying in our shelters every year.

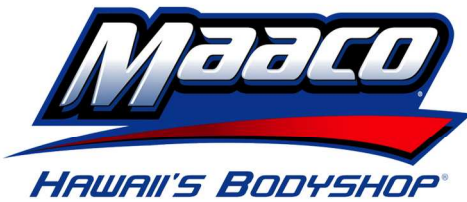
